This application is free and is only open to residents of Great Wakering who are over 80 years of age and on the electoral register. Proof is required to be shown to the Office of age.

For a chance of receiving a parcel you must complete, sign and return the form to the Parish Council Office by noon of the 7th of December 2025.

By submitting an application form you confirm that you are eligible to do so and that you are a resident of the Parish of Great Wakering and over 80 years of age. The Council will check applications to ensure entry conditions have been met.

There is a maximum of one parcel per household.

By submitting an application form you agree to be bound by these terms and conditions.

There is a limited supply of parcels and once the supply has been exhausted the giveaway will come to an end. Submitting an application form is not a guarantee that a parcel will be received, the application offers you a chance to receive the giveaway. We strongly advise that you return your application form as soon as possible.

There is no responsibility on Great Wakering Parish Council to meet or reply to any applications and the Council will not be held liable if the parcel becomes unavailable or the application cannot be fulfilled for any reason.

Great Wakering Parish Council will not be held liable for failure of receipt or loss of applications, the Council takes no responsibility for any applications which are lost, delayed, illegible, corrupted, damaged, incomplete, or otherwise invalid.

Successful applicants will be notified as soon as is practicably possible, it is our aim that all parcels will be delivered before Christmas 2025.

If a successful applicant does not respond to any contact regarding their parcel within 21 days, they will lose their right to receive the giveaway item and the Council reserves the right to select a new applicant to receive the item.

To the extent permitted by applicable law, the Council's liability under or in connection to the giveaway or these terms and conditions shall be limited to the cost price of the giveaway item.

To the extent permitted by applicable law the Council does not accept any liability for any loss, damage, injury, or disappointment suffered by any applicants as a result of submitting an application or being or not being selected to receive the giveaway item.

To the extent permitted by applicable law, the Council shall not be liable under or in any connection with these terms and conditions, the giveaway or the giveaway item for any indirect, special or consequential cost, loss or damage suffered by an applicant even if such cost, expense, loss or damage was reasonably foreseeable or might reasonably have been contemplated by the applicant and the Council and whether arising from breach of contract, tort, negligence, breach of statutory duty or otherwise.

The giveaway item is non-negotiable, non-exchangeable, non-transferable and non-refundable, no cash alternative is available.

In the event of unforeseen circumstances beyond the Council's reasonable control, the Council reserves the right to cancel, terminate, modify or suspend the giveaway or these terms and conditions, either in whole or in part, with or without notice.
